2. APPROVAL OF MINUTES – AUGUST 1, 2024

3. TOTAL ALTRUISM PROJECT GUEST PRESENTATION

Gary Blume, Total Altruism Project, and Kelly Wood, Total Altruism Project, provided a PowerPoint presentation, responded to Committee questions and expressed a desire to test the project at Big Rock Park.

4. STAFF REPORT/PARK DEVELOPMENT UPDATE

Nicholas Chavez, Director of Community Services, provided an update on the following topics: synthetic turf replacement project at Town Center Community Park, San Diego River Park Foundation art initiative at Mast Park, a homeless outreach event at Mast Park, pickleball improvements at Big Rock Park, and a grant submittal for a shade structure at Weston Park.

Anne Morrison, Recreation Services Manager, provided an update on the following topics: Santee Movie in the Park, Santee Brews and Bites Festival Fundraiser, Santee Holiday Lighting, recreation classes, senior programs, teen center programs, Town Center Community Park East rentals, an upcoming youth sports survey, and an upcoming disc golf tournament at Mast Park.

Committee Member Dressler inquired if roller skating was allowed on the basketball court at Mast Park, upon staff clarification, Chair Velasco asked staff if they would consider looking at amending the Municipal Code related to this topic; she also spoke about an opportunity her company is providing for non-profits to seek funding for their programs.
