Honorable Mayor and Members of the Council,

My name is Dani Gasparini. I served as Mayor of Redwood City and have remained deeply involved in local civic and nonprofit work throughout my career. I'm also a local partner in Embarc Redwood City.

As someone who spent years in public service, I know how difficult it can be to evaluate applicants and weigh the promises they make. I also know how rare it is to find a business that keeps their promises, let alone exceeds them as Embarc has done in our City.

Embarc was the first cannabis business to open in Redwood City, and to date, they remain the only cannabis operator in Redwood City to have fully delivered on their community benefit commitments. From the very beginning, they've taken their responsibility seriously by investing in programs, supporting local organizations, and ensuring their operations reflect the values of our community (diversity, equity, inclusion and hiring local talent).

Redwood City was a highly competitive process. The city was very skeptical and nervous about cannabis because Redwood City was the first City in the County and the entire peninsula to implement retail cannabis. All eyes were on Redwood City and the operators they selected to set the standard for retail cannabis implementation in our region. Embarc being the first to open, and opening in the heart of downtown Redwood City, was a big deal. Many were nervous. I was nervous, being a former Mayor, yet very supportive of this step in bringing retail cannabis to Redwood City. But Embarc exceeded everyone's expectations. Today, nearly 3 years after opening, Embarc's storefront continues to be viewed extremely positively by the City administration, elected officials and the community at large. They truly set the gold standard for what responsible, community-sensitive, and appropriate cannabis operations throughout our region.

I've worked closely with Lauren and Dustin over several years and truly value the partnership we have and the friendship we have built. They bring a level of industry knowledge and operational integrity to their business that is unmatched. They understand the complexities of local government. They understand the importance of public trust. And they've built a team top-to-bottom that reflects that seriousness in all of their operations. Not simply because I am directly involved with Embarc, but they have truly set the standard in Redwood City with their commitment to community, upholding all components of the ordinance and delivery on their community benefit.

As I understand it, Santee is evaluating cannabis operators now. I encourage you to look at the results in other communities where they operate, particularly Redwood City. Embarc has delivered time and time again, and I strongly recommend them as a true partner in successfully and responsibly implementing retail cannabis in the community. Their business model has exceeded my expectations.

Dear Mayor and Councilmembers,

My name is Rev. Dr. David C. Isom and I served as the Pastor of the St. Stephen CME Church in Fairfield for many years. I'm also the former President of the Board of the Fairfield-Suisun Unified School District where I served for 12 years.

I dedicated my life to serving the Fairfield community, particularly our youth, and I appreciate the opportunity to offer my support for Embarc's application in the City of Santee as a proud member of their Fairfield Community Advisory Board.

When it came time for the City of Fairfield to open dispensaries I was clear-eyed about the kind of accountability and care we needed from any cannabis business seeking to operate in our community.

When Embarc first approached me, I was extremely hesitant. I did not want to be involved in supporting cannabis given my role in youth education and as a Pastor. Yet, Embarc came and talked to the community early and often, and eventually built trust with a truly impressive group of local leaders who joined their Fairfield Community Advisory Board, which I eventually joined and have now served on for the past three years.

As someone who has really gotten to know the Embarc team, I can tell you that Embarc has always emphasized youth drug prevention and education as a core part of their mission. In Fairfield, Embarc has built partnerships and structures that support youth and local priorities. Their model is important because it allows for flexibility to address community needs as they arise. Their approach is informed, deliberate and guided by local input.

They welcome accountability, but to be honest, I can't remember a time I felt the need to hold them to account because they're so proactive about addressing community needs. I've seen how Embarc runs their stores from the very top of their management team to their most junior retail employee. They all show up when it matters and put the needs of the community first in their operations.

I know you are weighing this decision carefully. That's commendable. But if the City of Santee is going to allow cannabis retail, I know choosing Embarc is the right decision. They understand that protecting the community and the future of your youth must always be at the center of how they move forward. I am certain that they we be as great a community partner in Santee, as they are in Fairfield!

Dear Honorable Members of the Santee City Council,

I am writing to express my strong support for the selection of Catalyst - Santee for a cannabis business permit in your city.

As Orange County Supervisor for the Second District and former Mayor of the City of Santa Ana—one of the first jurisdictions in Orange County to implement a regulated cannabis program—I understand the critical role cities play in selecting operators who are not only compliant, but also committed to community well-being and long-term success.

During my time on the council, Santa Ana became one of the first municipalities in Southern California to allow for the licensing of cannabis retail businesses. Santa Ana voters passed Measure BB, which I supported with my vote. At the time of Santa Ana's initial permitting in 2015, there were many unknowns in the cannabis industry. Particularly, the businesses that would be the most successful at accomplishing the objectives of Santa Ana's cannabis program, proactive regulation, revenue generation, job creation, and social equity, were unknown.

Beyond their economic impact, Catalyst has demonstrated deep community commitment—hosting expungement clinics, blood drives, and a beloved annual Christmas tree giveaway. They've also established a distribution facility adjacent to their retail site, reflecting a long-term investment in the local economy.

Dear Mayor Minto and Councilmembers,

I'm reaching out with urgent and verifiable information that I believe you should consider before finalizing your licensing decisions tomorrow.

During recent interviews, multiple applicants claimed that they have never defaulted on payments to vendors. This is demonstrably false. Some of these same applicants, including March and Ash, currently owe tens of thousands of dollars to small, independent vendors — many of whom have been left unpaid for months or even years.

Worse, there is video evidence of the owner of Off the Charts (OTC) bragging about **intentionally stiffing** "mom-and-pop" vendors. This is a pattern of conduct that reflects how they do business.

I urge you to review the attached material and consider whether this is the kind of operator that should represent the City of Santee.

Dear Mayor and Councilmembers,

My name is Ron Turner. I served as a police officer for more than two decades in Fairfield. My son is currently a police Sergeant in Fairfield, so you could say public safety and service are values that run deeply in my family. I also served as the District Director for Senator Bill Dodd and now President of the 100 Club of Solano and Yolo Counties, supporting families of fallen first responders. Most relevant to your discussion, I'm the proud local owner of Embarc Fairfield and I am writing to share my experience and express my support.

I was raised to emphasize accountability, most importantly to the community I swore an oath to defend. I'll plainly say that when I first heard about Embarc, I had my fair share of doubts. Like most law enforcement officers, I was skeptical of cannabis legalization.

But what I found changed my perspective entirely on how cannabis can and should benefit the communities they serve. I have worked very closely with Lauren and Dustin for nearly 5 years now and am proud to be a part of the Embarc family.

Embarc operates with the professionalism and attention to detail that I expect from any business serving the public. Their security measures are comprehensive. Their compliance procedures are rigorous. Their community engagement is authentic. Lauren and Dustin are two of the most knowledgeable, professional and committed business people I've encountered in any industry, let alone among their peer cannabis operators.

In Fairfield, our Community Advisory Board, which I chair, uses the 1% of gross revenue that Embarc provides to a host of local needs. Ranging from support for the Police Activities League in Fairfield, which is near and dear to my heart, as well as youth drug education and prevention programs with local youth organizations. We support educational scholarships and faith-based organizations, food pantries and so much more. The Board model works as it ensures that we, as community leaders who know the needs in our community, are empowered to direct funds where and when they are most needed.

My son, who serves as a police Sergeant in Fairfield, has had only positive interactions with Embarc's operation there. Embarc often works with our local PD to help solve crimes that have nothing to do with their operations, but just to help local law enforcement through the utilization of their significantly advanced security systems, such as FLOCK in solving other crimes in the community.

I've visited Embarc locations across California and reviewed their operational procedures extensively. They consistently exceed regulatory requirements and

maintain the highest standards of public safety.

Based on my law enforcement experience and direct observation of their operations, I can confidently recommend Embarc as a responsible operator who will serve Santee professionally and safely.

Dear Santee Mayor and City Councilmembers,

I am Tammie Helmuth and I serve as the CEO of the Girl Scouts of California's Central Coast. While I've never been supportive of cannabis, I want to offer my full support for Embarc. I'm proud to serve on their Community Advisory Board in Ventura and I'm happy to speak to how they show up for our community because they've proven themselves to be a committed partner.

I joined Embarc's Community Advisory Board because I wanted to ensure the financial benefits of cannabis were invested in our most promising residents – our youth. Through their sole financial support, we launched the Botvin LifeSkills program, an evidencebased youth drug prevention and education curriculum that's made a real impact on the young women and girls we serve. We launched this program in partnership with our Ventura County Sheriff's Department. When I first met with Devon over 4 years ago now, she promised that Embarc's community funding would prioritize the protection and education of our youth with a focus on drug prevention – and that is exactly what Embarc has done.

Embarc is also committed to being partner in the community. Not just in terms of financial benefits, but in terms of "showing up". Their in-store staff have volunteered with us, showing up at a parking lot before sunrise to distribute over a million boxes of Girl Scout cookies at our annual Mega Drop. In addition, at Advisory Board meeting, they ask how they can support our mission and then they deliver by volunteering at our events. That kind of proactivity is rare, and it speaks volumes about their values and the way they do business in the community.

Embarc was the first dispensary to open in the City of Ventura and while I did not support retail cannabis stores, I will continue to support Embarc. They have integrated safely and sensitively into the community and are located in the heart of midtown Ventura. Their team goes above and beyond to improve their neighborhood through regular clean-ups, collaborations with near-by businesses and remaining extremely attentive to community needs. In fact, just last month I was at an event with an Embarc staff member and folks came up to thank them for consistently picking up trash near their storefront. They have also been a catalyst for economic growth. The Ventura licensing process was very controversial and difficult, and with Embarc being the first to open – they set the standard for responsible retail cannabis. Today, cannabis in Ventura is viewed very positively by both community leaders and elected officials, without regret.

I must tell you that I never thought I would be writing a letter in support of a cannabis company. But Embarc has not only earned my trust but also my respect in supporting drug prevention education as they promised. This must be front of mind in your positions. Embarc is the only cannabis company that I have seen invest in this area. Not only in our city, but throughout the communities they are in. It is part of their DNA and this investment and commitment shouldn't be overlooked! If you're looking for an operator that understands real partnership and community engagement, I'm confident you can't find better than Embarc. I haven't.

My name is Terry. I am a former Police Officer for the City of Chico. I had the distinct honor to serve as President of the Chico Police Officers' Association for many years. Public safety has been the focal point of my life.

When it came time for Chico to consider opening our doors to cannabis, I approached the issue with the same lens I do for any issue. What is safest for our community, and who can we trust to do things right?

In Chico, that answer was clearly Embarc.

From a law enforcement officer's point of view, Embarc is, and has been, a model operator. Their security standards are rigorous and I believe they exceed requirements. The Embarc staff are well-trained and their overall approach reflects a real understanding of what responsible integration into a community should look like.
