ITEM TITLE REPORT ON COMMUNITY PLAYGROUND SURVEY

BACKGROUND

A community playground survey was open to the public from March 5, 2025 through April 2, 2025. The recent playground survey gathered 476 responses from our community, providing valuable insights into residents' preferences and expectations for our parks. The survey focused on key elements such as desired playground features, visiting age demographics, and factors influencing park visits.
