The undersigned participant and/or parent, guardian or notary acknowledge that The City of Santee, as a part of its Skate and BMX Park Program at Woodglen Vista has created a Skate and BMX park designed to enhance the coordination and physical condition of participants as well as provide the community with an all-ages recreation facility. The undersigned persons acknowledge further that The City of Santee has taken reasonable precautions to assure that the Skate and BMX Park program will provide a safe experience for participants. The undersigned also acknowledges that the sports of skateboarding, in-line skating, kick scooters and BMX riding are hazardous and dangerous recreational activities that involve numerous risks of injury, including death, and the undersigned freely assumes those risks. The undersigned is aware that the risks involved necessarily increase when using ramps, curbs, steps, half-pipes, rails, inclines or declines, bowls or any other structure or device. The undersigned is further aware that the risks, hazards and dangers include, but are not limited to, uncontrollable skateboards, falling, jumping, landing, performing tricks, colliding with other users, staff, media personnel and spectators. The undersigned also understands that these risks, hazards, and dangers are further increased when other persons, whether or not of the same level of experience or skill, are present at the same time and using the same facilities. The undersigned persons also acknowledge that the participant is in good general health and physically fit to participate in the program. The undersigned persons acknowledge and agree that neither The City of Santee nor any facilitator or employee of the Woodglen Vista Skate and BMX Park shall be liable for any occurrence in connection with the Skate and BMX Park Program that my result in injury or other damages, including death, to the undersigned participant. The undersigned further agrees to indemnify, hold harmless and to defend The City of Santee, and all persons associated with it, from any claim or in any legal action by the undersigned participant or family, estate or heirs arising out of the participant's enrollment and participation in the Skate and BMX Park Program, with the exception of such claim or legal action arising solely from the gross negligence of the City of Santee. **THE CITY OF SANTEE DOES NOT PROVIDE MEDICAL OR ACCIDENTAL INSURANCE FOR PERSONS INVOLVED IN PROGRAMS SPONSORED BY THE CITY OF SANTEE'S DEPARTMENT OF COMMUNITY SERVICES.** The undersigned persons acknowledge that enrollment in The City of Santee's Skate and BMX Park is entirely voluntary, and that in consideration of being able to enroll and participate in a course, the undersigned persons hereby assume all risks related to the Skate and BMX Park for any injury or damage to persons or property that may result while the undersigned participant is enrolled in the Skate and BMX Park Program and the undersigned assume all risks connected with participation in the Skate and BMX Park Program, whether foreseen or unforeseen. The undersigned hereby authorizes the administrators/staff of this program to provide secure reasonable and necessary emergency medical treatment for his/her self/child for injuries sustained while participating in this program. The undersigned further agrees to pay for such reasonable and necessary medical care upon presentation of the medical provider's bill or statement. The undersigned hereby permits the Community Service Department to use and publish photographs and/or videotapes of his/her self/child for purposes of presenting recreation activities to the community and to promote the recreation program to prospective clients and/or participants. The undersigned also gives permission to release such photographs and/or vidoe tapes to the news media in support of the program. Skate Park Rules

1. The Santee Skate Park is for skateboarding, rollerblading, scooters, bicycles, and wheelchairs. All other uses are prohibited, NO MOTORIZED VEHICLES ALLOWED.
2. Recreational skating and biking have separate designated sessions for safety purposes. Users are required to utilize the park during the appropriate session.
3. All park users must have a signed liability waiver on file. For registrants under 18 years of age, a parent or guardian must sign waiver in person, or have waiver notarized.
4. All park users must complete the registration process on an annual basis
5. Minimum age for skaters/riders without adult supervision is (six) 6 years old. Children 6 years or under must have a parent/guardian present at all times.
6. All park users must wear the appropriate safety gear, which includes: helmet, elbow pads, knee pads, shirt, and appropriate shoes. In addition, wrist guards are strongly recommended. Failure to wear protective gear may result in loss of park privileges for the day.
7. All park users must skate/ride safely at all times, and avoid collisions with others. Fighting or other aggressive, disruptive, or rude behavior will result in ejection from the park, and users may not be permitted back without the approval of park staff.
8. All equipment used by skaters/riders must be in good condition, and must not damage park or its structures.
9. Spectators are required to remain in the designated spectator area.
10. All forms of graffiti, tagging, or other means of defacing City of Santee property is strictly prohibited. Such activity will be reported to the Santee Sheriff's Department and may result in closure of the facility until it can be cleaned and/or repaired. Violators will be ejected and not permitted back without the approval of the City staff, and may be prosecuted/fined (SMC 9.56.010).
11. Food, drinks, or glass containers are prohibited within Skate/BMX Park area.
12. Drugs, alcohol, weapons, and profanity are prohibited.
13. Smoking and/or vaping within the skate park area is prohibited.
14. Skating/biking/scooters in the basketball and tennis court is prohibited (SMC 10.40.020).
15. Skating/biking/scooters on brickwork, planters, or other ornamental surfaces is prohibited (SMC 10.40.020).
16. Items such as benches, tables, wood materials, or other objects used as ramps or jumps are not allowed in the park. Modifications to the park are prohibited.
17. All BMX bicycle pegs must be plastic or adequately covered during use inside the park.
18. The City of Santee reserves the right to change the Park's schedule as necessary.

I acknowledge that I have read, understand, and agree to follow the SKATE park rules that have been provided to me. Failure to abide by these rules shall be the cause for ejection from the Santee Skate Park.
